2. Hearing of citizens.
3. Discuss, consider and approve name/theme for capital campaign for school growth. ND
4. Discuss, consider and approve possible salary increases or stipends for teachers, including but not limited to, the Special Education certified stipend. BD
5. Discuss, consider and approve an amendment to ESSER II and ESSER III applications to include a one time retention stipend for 2021-2022 returning employees and again for 2022-2023 returning employees. BD
6. Adjourn to closed or executive session pursuant to Texas Government Code Section 551.071 For the purpose of a private consultation with the board's attorney on all subjects or matter authorized by law when the governmental body seeks the advice of its attorney about a pending or contemplated litigation or a settlement offer; or on a matter in which the duty of the attorney to the governmental body under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas Clearly conflicts with this chapter.
 - a. Consider legal advice regarding any item on the agenda;
 - b. Consider legal advice regarding possible approval of the settlement agreement in the special education due process hearings, TEA Docket Numbers 215-SE-0411 and 216-SE-0422, and related actions.
7. Reconvene in open session.
8. Consider and take possible action to approve the settlement in two special education due process hearings, TEA Docket Numbers 215-SE-0411 and 216-SE-0422, and related actions from closed session.
9. Adjourn.

Additional Closed or Executive Session Authority

Should any final action, final decision, or final vote be required in the opinion of the Board with regard to any matter considered in such closed or executive session, then such final action, final decision, or final vote shall be at either:

- (a) The open meeting covered by this Notice upon the reconvening of this public meeting, or
- (b) A subsequent public meeting of the Board upon Notice thereof, as the Board shall determine.

The items listed in this notice may be considered in any order at the discretion of the Board of Directors or the Board President, items listed for closed session discussion may be discussed in open session, and items listed in this notice may be tabled and considered at a subsequent public meeting of the Board of Directors upon proper notice.
